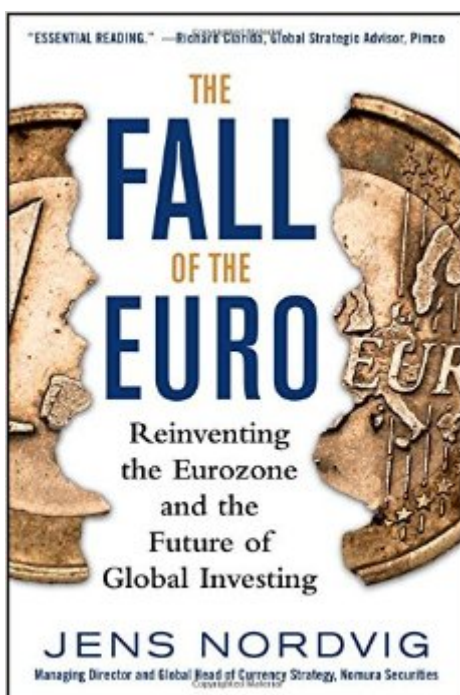

Mr. Nordvig provides unparalleled insights into the uncertain future facing the Eurozone economies and the Euro. He delivers a comprehensive analysis of a) the historical perspective on how the Euro experiment came to fruition, evolved over time, and comparisons to other currency unions, b) the current landscape, the economic consequences of a union, and the unstable equilibrium between politics and economics, and c) an ingenious assessment of future outcomes. By exposing the

inherent flaws and instability that are plaguing the system, a thought provoking discussion unfolds that examines what is necessary to maintain the current arrangement, the likelihood of various break-up scenarios, the mechanics of a break-up, along with the associated economic, political, and financial market implications.
