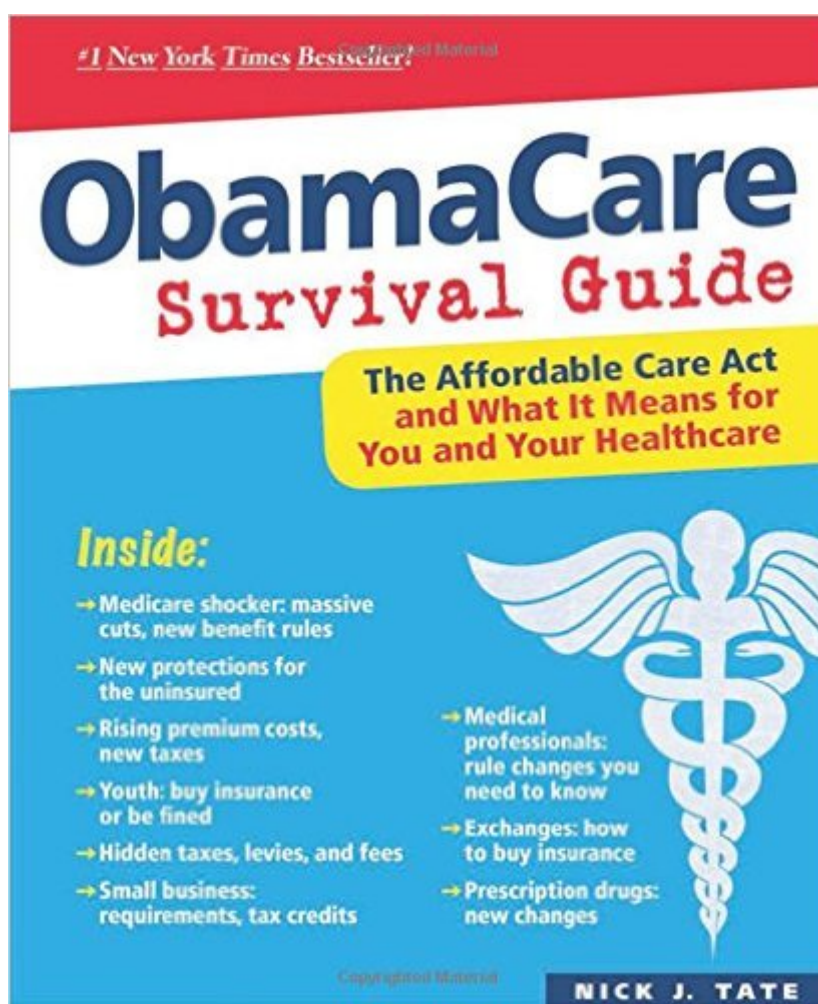

But the sub-title of "The Affordable Care Act and What It Means for You and Your Healthcare" is actually a little more accurate. This is a brief (although biased) guide to the new Healthcare laws coming into effect. There are several different sections; "Welcome to ObamaCare", "ObamaCare: What It Means for You", "ObamaCare: A Multiyear Timetable", "Health Insurance: Radical Changes Ahead", "The Individual Mandate", "The Expansion of Medicaid", "Health Insurance Exchanges", "Incentives for Small Businesses", "More Benefits, Higher Costs", "Turning the Screws on Medicare", "Cost Control Experiments", "Making Americans Healthier", "Long-term Care", "ObamaCare, Etc.", "ObamaCare's Price Tag", "Protect Yourself Against ObamaCare", and the appendices. As you can tell from the titles of these chapters, the book tries to go into explanation on each part of the new Healthcare law. A lot of it is summary and supposition, but there are genuine facts from the law in here. I especially found the section on Long-Term care to be informative. Especially where it described the new laws that would monitor care at Nursing Homes and make a report available to the public.
